**WHEREAS**, the budget is limited to carry-over and annual revenue; and,

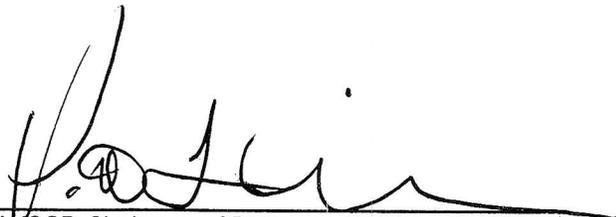
**WHEREAS**, the total budget expenditures will not exceed \$607,945;
