



**RESOLUTION No. 359-83**

**OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO**

CALLING AN ELECTION TO BE HELD IN THE PROPOSED  
GOLDEN WEST COMMUNITY SERVICES DISTRICT TO DETERMINE  
WHETHER OR NOT SAID DISTRICT SHALL BE ORGANIZED

WHEREAS, a petition has been submitted to the Board of Supervisors of the County of El Dorado proposing the formation of the Golden West Community Services District, and

WHEREAS, said proposal was approved by the El Dorado County Local Agency Formation Commission on November 3, 1983 by Resolution of said Commission No. L-83-43, and

WHEREAS, the Board of Supervisors has called a hearing on the proposed formation and has given notice of said hearing in accordance with law, and

WHEREAS, at said hearing all persons speaking for or against said district were heard, and

WHEREAS, the Board of Supervisors of the County of El Dorado has examined the petition for formation of the Golden West Community Services District, and has determined that said petition complies with the Community Services District Law, and

WHEREAS, the Board of Supervisors has determined that all lands described in the petition will be benefited by the said proposed district, and that said district will be in the public interest and is economically feasible, and

WHEREAS, the Board of Supervisors has determined that an election is required to be held in the proposed district for the

purpose of determining whether or not the district shall be formed and for the selection of persons who shall serve as the directors of said district if said district is formed,

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of El Dorado that the boundaries of the proposed Golden West Community Services District are hereby fixed as described in Exhibit "A" attached to this Resolution and incorporated herein by this reference, and

BE IT FURTHER RESOLVED that in accordance with Chapter 3 (commencing with Section 61120) of Division 3 of Title 6 of the Government Code, the Board of Supervisors of the County of El Dorado hereby calls an election to be held in the proposed Golden West Community Services District to be held on the next established election date of April 10, 1984, at which a Board of Directors consisting of five (5) members shall be elected upon a favorable vote for formation of the district and at which the following question shall be considered:

1. Shall the Golden West Community Services District be formed?

and,

BE IT FURTHER RESOLVED that the name of said district is hereby fixed by the Board of Supervisors as required by law, as the Golden West Community Services District, and

BE IT FURTHER RESOLVED that the Clerk of the Board of Supervisors is hereby directed to transmit to the Executive Officer of the El Dorado County Local Agency Formation Commission

within five (5) days of the adoption of this resolution, a notice of this resolution calling an election in accordance with Section 61122.1 of the Government Code, and

BE IT FURTHER RESOLVED that the election shall be conducted in accordance with said Chapter 3 (commencing with Section 61120) of Division 3 of Title 6 of the Government Code.

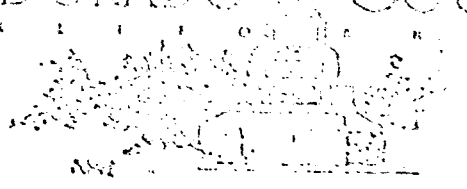
