The Golden West Community Services District (GWCS D), County of El Dorado, State of California, having received an application as presented herein, upon completion of this form and collection of the administrative fee, hereby grants a revocable permit for the above parcel under the following conditions:

1. Driveway and culvert construction plan shall meet the requirements of El Dorado County Design Standard 103B-1 (attached)
2. Plans for the encroachment work must be approved before work is started.
3. In the event future improvements or maintenance of the right of way necessitate relocation of the encroachment, the landowner will relocate the encroachment at his sole expense.
4. Provisions of the encroachment permit must be met prior to occupancy of a new residence.
5. This permit does not grant permission to work on others property. It is the applicant's responsibility to determine property lines and right of ways.
6. Landscaping within GWCS D right of way shall not exceed 18" in height.
7. Mailbox location shall not restrict the ability to maintain the roadside ditches.
8. The landowner, or his successor in interest, is responsible for the proper maintenance of encroachment covered by this permit.
9. This permit may be revoked at any time, without cause, by resolution of the GWCS D Board of Directors and is subject to all of the requirements and provisions of the GWCS D Ordinance 1 and Ordinance 5.

- A = ANGLE OF DRIVEWAY CENTERLINE IN RELATION TO ROAD CENTERLINE, THE ANGLE WILL BE BETWEEN 70°-100°
- DRIVEWAY STRUCTURAL SECTION IS 2 1/2" ASPHALT CONCRETE AND 4" OF AGGREGATE BASE.
- THOSE DRIVEWAYS EXCEEDING 20% EITHER UP OR DOWN IN GRADE, WILL REQUIRE A GRADING PERMIT.
- NO PORTION OF A DRIVEWAY WILL BE WITHIN 25' FROM A RADIUS RETURN, NOR 10' FROM A FIRE HYDRANT.
- MINOR COLLECTORS WILL REQUIRE MAXIMUM WIDTH DIMENSION ON DRIVEWAY.
