Beginning at 6340 Crystal Blvd. Continuing approx. 300 ft North, remove material in ditch to a minimum depth of 6". New surface shall include 4" of $\frac{3}{4}$ base rocks and place compacted $\frac{1}{2}$ " black top in multiple lifts for a total of $2\frac{1}{2}$ ". Create an A/C dyke along entire 300 ft ditch line.

All materials removed shall be placed and graded in the GWCSD common area as directed by the GWCSD General Manager.

Metal grate bars, to be prevent large debris from entering the drain inlet shall be installed.

Place 100 road reflector markers along fog line as directed by the GWCSD General Manager.
