## ORDINANCE NO. 3

### OF THE GOLDEN WEST COMMUNITY SERVICES DISTRICT OF THE COUNTY OF EL DORADO

The following public roads, which connect to Crystal Boulevard, are to be posted with stop signs thirty days after the passage of resolution 94-5, which empowers Ordinance No. 3:


- Barite
- Talcite
- Obrizo
- Amalgam
- Cinnabar
- Silva Way
- Mica
- Calcite
- Ferrite

These public roads are side roads which are within the GWCSO boundaries and are under the control of the GWCSO. It shall be illegal to fail to come to a complete stop at any posted stop sign location adopted by Board resolution. Failure to stop shall be a misdemeanor punishable by fine or imprisonment as stated in state law or El Dorado County traffic enforcement code, and shall be enforceable by appropriate public law enforcement authorities.

## RESOLUTION NUMBER 94-5

A RESOLUTION ADOPTING ORDINANCE NUMBER 3 FOR THE BOARD OF DIRECTORS OF THE GOLDEN WEST COMMUNITY SERVICES DISTRICT WHICH INCORPORATES DEFINITIONS OF THE STOP SIGN LOCATIONS ON SIDE ROADS ENTERING CRYSTAL BOULEVARD. THESE STOPS SIGNS ARE TO BE OFFICIALLY OBSERVED AS LEGAL STOPS BY ALL VEHICLES TRAVELLING ONTO CRYSTAL BOULEVARD FROM ADJOINING SIDE ROADS.

Whereas all elected bodies require defined policies to direct their officers to develop procedures and provide services within the powers invested to them by the people they represent; and

Whereas the Golden West Community Services District is responsible for providing road improvement and road maintenance under LAFCO Resolution L-83-43 and as authorized under California Government Code Section 61,600 subdivision (j) and (k); and

Whereas there are existing asphalt pads which have had the word "STOP" as well as a stop line already painted on them at the access to side roads entering onto Crystal Boulevard; and

Whereas the Board Members of the Golden West Community Services District have approved the placement of stop signs on the side roads entering onto Crystal Boulevard as necessary to implement safer access to Crystal Boulevard:

NOW, THEREFORE, THE BOARD OF DIRECTORS OF THE GOLDEN WEST COMMUNITY SERVICES DISTRICT DOES RESOLVE THAT ORDINANCE NO. 3 SHALL BE ADOPTED AND THAT ALL STOP SIGNS POSTED ON THE FOLLOWING SIDE ROADS CONNECTING TO CRYSTAL BOULEVARD SHALL BE DESIGNATED AS REQUIRED LEGAL STOPS AS SOON AS THE SIGNS ARE IN PLACE, WHICH SHALL BE NO SOONER THAN 30 DAYS AFTER THIS RESOLUTION IS APPROVED BY THE GWCSO BOARD: BARITE, AMALGAM, MICA, TALCITE, CINNABAR, CALCITE, OBRIZO, SILVA WAY, SODALITE, and FERRITE.
