Moved by Dir Orrick, seconded by Dir Hill to approve special meeting agenda. Motion approved unanimously.

**1. New Business**

- **Contract to Repair Storm-Related Subsidence in Crystal Ditch.** The Board will consider and possibly approve a contract to repair subsidence on the northern portion of the western edge of Crystal Ditch.

Board Discussion/Public Comment/Board Action

About 80' of Crystal hillside on west side around 6200 is washing down into ditch and into road in heavy rains. GM White met with Vicini representative to walk the problem area and discuss possible solutions. Resulting proposal is \$5745. GM White recommends 10% contingency in case of extenuating circumstances.

Dir Orrick moved, Dir Hill seconded to approve a contract with Vicini not to exceed \$6250 (proposal plus 10% contingency) to repair this section of Crystal Blvd. Motion approved unanimously.
